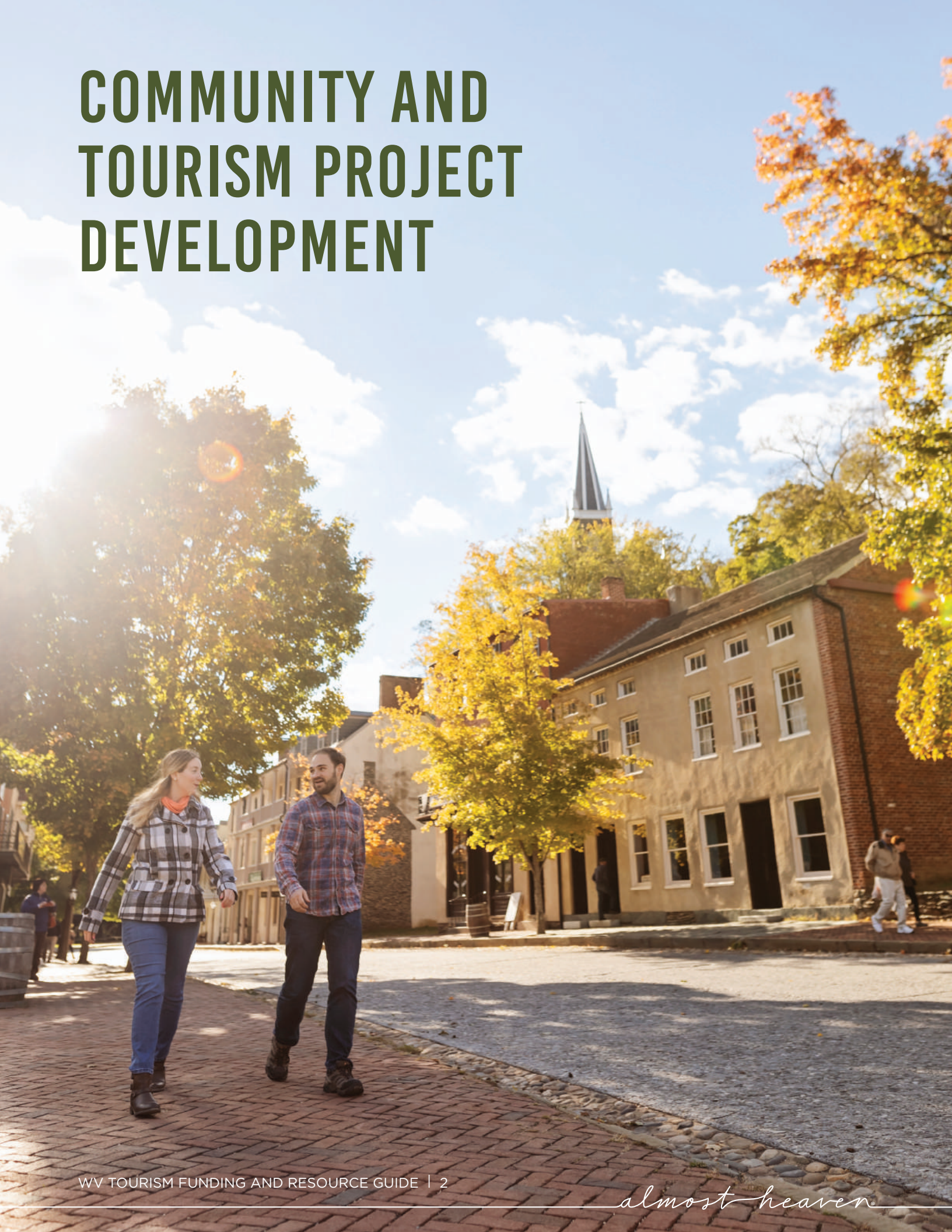

# CLAUDE WORTHINGTON BENEDUM FOUNDATION ECONOMIC DEVELOPMENT GRANTS

**FUNDING TYPE** | Nonprofit • Private Donations Grant

## DESCRIPTION

The Benedum Foundation’s agenda seeks to promote regional planning and cooperation, recognizing that with respect to any endeavor, “region” should mean whatever area is most appropriate to optimize the available opportunity, without reference to historic, geographic, or political boundaries.

## ELIGIBILITY

The foundation serves communities in the region that are rural and enjoy abundant natural assets that provide economic opportunities that complement centers of technology-based growth. The foundation supports efforts to advance agriculture, outdoor recreation, artisanship, and cultural tourism.

**Specific areas of interest include:**

- › Promotions of entrepreneurship
- › Projects that promote technology-based economic development

# Community and Tourism Project Development

## NATIONAL COAL HERITAGE AREA (NCHA) GRANT

**FUNDING TYPE** | Federal

### DESCRIPTION

NCHA grants are designed to support community efforts to preserve, interpret and promote the coal mining heritage of southern West Virginia. Projects must be implemented within the following counties: Boone, Cabell, Fayette, Lincoln, Logan, McDowell, Mercer, Mingo, Raleigh, Summers, Wayne, Wyoming, and the Paint Creek and Cabin Creek watersheds in Kanawha. The National Coal Heritage Area management plan identifies interpretive themes for the area, which include business of coal mining; working in coal; the company town; mining technology; and crisis and renewal. Projects are funded at a dollar-for-dollar match. Mini-grants are not to exceed \$5,000. Major grants are for projects requesting over \$5,000.

### ELIGIBILITY

**Eligible applicants include:**

- > Legally established nonprofit organizations and institutions
- > Public and governmental organizations including county and municipal governments State agencies
- > Economic development authorities Educational institutions

Each project must address at least one of the interpretive themes identified in the National Coal Heritage Area management plan. The most recent interpretive themes include interpretation and heritage programming, historic preservation and resource stewardship, archives, and historical records collection, greenways, public parks and non-motorized trails, educational activities, and events. Previous projects have included the preservation of archival materials, preservation of historic structures, creation of museum exhibits, and creation and production of brochures and marketing materials.

**ADMINISTERING AGENCY** | National Coal Heritage Area Authority - Oak Hill, WV

**CYCLES** | Completed applications are due within four separate grant periods for mini-grants and one period for major grants - based on prior year grant schedule:

1st Grant Period: Applications for major and mini-grants must be submitted by March 4

2nd Grant Period: Applications for mini-grants must be submitted by June 3

3rd Grand Period: Applications for mini-grants must be submitted by September 2

4th Grant Period: Applications for mini-grants must be submitted by December 2

## PARTNER COMMUNITY CAPITAL (PCAP)

**FUNDING TYPE** | Loan • Technical Assistance

### DESCRIPTION

Partner Community Capital (PCAP) helps small businesses get the capital and other resources they need but can't access. PCAP delivers flexible, affordable loans to borrowers in underserved communities, and connects clients to strategic advisory services so they can make the best use of PCAP's capital.

PCAP also provides more than just loans. PCAP recognizes that small enterprises often need more than just capital to succeed. They help to connect their customers with business advisory services. Some of these services include loan structuring, woman's business center advising, training or workshops, special programs and targeted technical assistance, and referrals and coordination.

### ELIGIBILITY

Small businesses, agricultural enterprises, and non-profits in underserved areas are eligible. PCAP also serves borrowers who cannot meet the credit standards of traditional financial institutions because of risks, real or perceived: they are too young, undercapitalized, or in an unfamiliar industry, geography, or demographic group.

# Community and Tourism Project Development

## APPALACHIAN REGIONAL COMMISSION (ARC)

**FUNDING TYPE** | Federal Grant

### DESCRIPTION

This commission represents a partnership between the federal government and the governors of thirteen (13) states that make up the ARC region. The president appoints a co-chair to represent the federal government and there is a selected governor who represents the thirteen states. The chair and the states must agree to any kind of budget and a grant is set into motion.

### ELIGIBILITY

Local governments, state governments, or non-profit organizations

**Eligible projects include:**

- > Creating or retaining jobs or businesses
- > Workforce development
- > Providing a foundation for economic development (infrastructure, site development, broadband)
- > Planning grants
- > Capitalizing loan funds
- > Business development training

**ADMINISTERING AGENCY** | West Virginia Department of Economic Development

**CYCLES** | Applications are received on an annual basis, normally in the fall of each year - based on prior year's grant schedule. Dates can vary each year depending on when the federal allocations are received.

# Community and Tourism Project Development COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)

**FUNDING TYPE** | Federal Grant

## DESCRIPTION

CDBG is a grant given to states to disburse to local governments (towns, cities, and counties) and is distributed through a need-based formula. The primary objective of the Housing and Community Development Act of 1974 is to develop sustainable satisfactory communities by providing decent housing, a suitable living environment, and expanded economic opportunities (principally for persons of low to moderate income).

## ELIGIBILITY

Local governments that do not receive CDBG direct funding from the U.S.

› Department of Housing and Urban Development

### Eligible projects include:

- › Public infrastructure projects: waterline extensions, replacement of water storage tanks, and wastewater treatment plants, with a cap of \$1.5 million
- › Community development projects: downtown revitalization, storm drainage improvements, broadband development, and demolition, with a cap of \$500,000
- › Planning projects: broadband planning and infrastructure design grants, with a cap of \$100,000 and 10% local match

**ADMINISTERING AGENCY** | West Virginia Department of Economic Development

**CYCLES** | Applications are received on an annual basis, normally in May with awards announced in December - based on prior year's grant schedule. Dates can vary each year depending on when the federal allocations are received.

# Community and Tourism Project Development COMMUNITY SERVICES BLOCK GRANT (CSBG)

**FUNDING TYPE** | Federal Grant

## DESCRIPTION

CSBG is a federal anti-poverty program administered by the Community Advancement and Development Office. The purpose in West Virginia is to aid a network of 16 Community Action Agencies (CAAs) and other statewide organizations in the reduction of poverty, revitalization of low-income communities, and to provide economic opportunities for low-income families.

CSBG funding supports projects that lessen poverty in communities; address the needs of low-income individuals including the homeless, migrants, and the elderly; provide services and activities addressing employment, education, better use of available income, housing, nutrition, and emergency and health services.

## ELIGIBILITY

Organizations that were officially designated as Community Action Agencies (CAAs) under the Economic Opportunity Act of 1964 and were specifically designated by the 1981 CSBG Act as eligible entities to receive CSBG funds. All recipients of CSBG funds submit community action plans and budgets detailing the programs, services, and activities to be conducted using CSBG funding.

**With the support of CSBG funding, states and CAAs work together to achieve the following goals for low-income individuals:**

- > Increased self-sufficiency
- > Improved living conditions
- > Ownership of and pride in their communities
- > Strong family and support systems

Working together, agencies increase their capacity to achieve results. Partnerships among supporters and providers of services play a large role in the successful implementation of CSBG grants.

**ADMINISTERING AGENCY** | West Virginia Department of Economic Development

**CYCLES** | CSBG grants are awarded on an annual basis and cover a period of two years. The normal grant cycle is October 1 - September 30 - based on prior year's grant schedule. Dates can vary each year depending on when the federal allocations are received.

## TOURISM DEVELOPMENT ACT TAX CREDIT (TDA)

**FUNDING TYPE** | Tax Credit

### DESCRIPTION

The TDA tax credit program encourages the expansion of tourism development projects. Businesses eligible for the program will receive a 25% tax credit from consumers' sales tax collected on the gross receipts generated from daily operations. The credit will be given over a 10-year period at the rate of one-tenth of the amount per taxable year. The credit can be up to 35% if the project is adjacent to or in a state or national park or is located on a former surface mine land.

### ELIGIBILITY

**Qualifier:**

- > A minimum of \$1 million in investment
- > Must be open to the public a minimum of 100 days a year
- > At least 25% of the visitors must be from out of state
- > No more than 50% of a project can be for lodging
- > Create a significant and positive impact on the state
- > Provide additional employment opportunities in the state
- > There is a \$10,000 application fee

## GOVERNOR'S GUARANTEED WORKFORCE PROGRAM

**FUNDING TYPE** | Workforce Training

### DESCRIPTION

This vital program provides new or expanding companies training funds and technical assistance to support effective employee training strategies. This program is not limited to new employees, but instead targets the business's entire workforce training, re-training, and upgrading skills across all levels. Awards cannot exceed \$2,000 per trainee.

### ELIGIBILITY

Overall funding levels are based on average starting wages and benefits, location of your facility, number of employees, and number of employees being trained.

# MAIN STREET WEST VIRGINIA AND WEST VIRGINIA ON TRAC

**FUNDING TYPE** | Training • Technical Assistance • Support

## DESCRIPTION

Main Street West Virginia and West Virginia ON TRAC are downtown revitalization programs that follow the National Main Street Center’s community-based approach to preservation and development. A subsidiary of The National Trust for Historic Preservation, Main Street is a successful community development model used in thousands of communities across the country.

ON TRAC is a West Virginia-created program for pre-Main Street communities to learn the basics of the Main Street Approach. A community must participate in ON TRAC for at least 2 years before being eligible for Main Street certification.

## ELIGIBILITY

**West Virginia Development Office staff provide training, technical assistance, and ongoing support to designated West Virginia communities in implementing transformation strategies using the Main Street four point Approach:**

Economic vitality focuses on economic and financial tools to assist new and existing businesses, catalyze property development, and create supportive environments for entrepreneurs to drive local economies.

Design supports a community’s transformation by enhancing the physical and visual assets that set the commercial district apart.

Promotion positions the downtown or commercial district as the center of the community and hub of economic activity, while creating a positive image that showcases a community’s unique characteristics.

Organization involves creating a strong foundation for a sustainable revitalization effort, including cultivating partnerships, community involvement, and resources for the district. Local Main Street organizations follow the Main Street National Accreditation Standards and are certified every year. There are 13 certified Main Street organizations in West Virginia.

**ADMINISTERING AGENCY** | West Virginia Department of Economic Development

**CYCLES** | Local Main Street organizations follow the Main Street national accreditation standards and are certified annually. A community must participate in West Virginia ON TRAC for at least 2 years before being eligible for Main Street certification. Applications for West Virginia ON TRAC and Main Street West Virginia is accepted every 3 – 4 years.

# WEST VIRGINIA NEIGHBORHOOD INVESTMENT PROGRAM (NIP)

**FUNDING TYPE** | Tax Credit Program

## DESCRIPTION

The NIP is a tax credit program of \$3 million each year, which allows 501(c)3 designated charitable organizations to apply for tax credit vouchers. When awarded, the organization can distribute the vouchers to businesses and individuals who contribute a minimum of \$500 to organizations, receiving up to 50% in tax credit, allowing the donor or corporation to reduce their West Virginia tax liability no more than 50%.

## ELIGIBILITY

The applicant must be registered with the Secretary of State as a 501(c)3, have a letter from the IRS stating they are non-profit, serve citizens in the state of West Virginia, have a local board, submit various financial documentation and attend a mandatory workshop to apply by June 30 each year.

**Projects generally eligible for program participation include but are not limited to the Following:**

- > Health clinics
- > Educational programs
- > Domestic violence shelters
- > Meal delivery programs
- > Community foundations
- > Hospice care
- > Daycare centers
- > Services for the disabled
- > Homeless shelters
- > Housing programs Preservation/revitalization activities
- > Children's shelters
- > Senior citizen centers
- > Scholarship programs
- > Transportation programs
- > Counseling services

**ADMINISTERING AGENCY** | West Virginia Department of Economic Development

**CYCLES** | Funding cycle is from July 1 to June 30.

# WEST VIRGINIA ECONOMIC DEVELOPMENT AUTHORITY (WVEDA) DIRECT LENDING PROGRAM

**FUNDING TYPE** | Loan Program

## DESCRIPTION

The Direct Loan Program is for applicants seeking a loan from the WVDEA in the minimum amount of \$50,000 and a maximum amount of \$10,000,000. The WVDEA has a two-tiered pricing system. For loans \$50,000 to \$1,000,000, the interest rate is fixed at closing using Wall Street Journal Prime times 75%. The interest rate for loans above \$1,000,000 is fixed at closing at the U.S. Treasury Note rate plus three quarters of one percent and the interest rate adjust every five years. All loans have a floor of 2.75% and no ceiling.

## ELIGIBILITY

This loan program is for applicants seeking a minimum WVEDA participation of \$50,000 and a maximum of \$10,000,000 and cannot be used in conjunction with other WVEDA direct programs.

**ADMINISTERING AGENCY** | West Virginia Economic Development Authority

**CYCLES** | Loan applicants are requested to submit pre-application information to allow WVEDA to determine project eligibility.

## WEST VIRGINIA HOUSING DEVELOPMENT FUND (WVHDF)

**FUNDING TYPE** | Mortgage Loans

### DESCRIPTION

The West Virginia Housing Development Fund was established by the state in 1968, to help increase the supply of residential housing and provide construction and permanent mortgage financing to public and private sponsors of such housing. WVHDF partners with numerous state-based banks, credit unions, and mortgage lenders.

### ELIGIBILITY

#### Homeownership

› Program for first-time buyers, offering great rates and closing cost assistance

#### Movin' Up

› Assistance for those looking to buy a larger home in West Virginia, closing cost assistance is available

#### Refinance Program

› Assistance for those looking to refinance an existing home in West Virginia

**CYCLES** | Applications are accepted throughout the year.

# WEST VIRGINIA SMALL BUSINESS DEVELOPMENT CENTER: SMALL BUSINESS INNOVATIVE RESEARCH (SBIR) AND SMALL BUSINESS TECHNOLOGY TRANSFER (STTR) ENTREPRENEURSHIP AND INNOVATION INVESTMENT FUND

**FUNDING TYPE** | State Grant

## DESCRIPTION

To foster job creation and economic development in the state and to stimulate SBIR and STTR activity in West Virginia, the SBIR Entrepreneurship and Innovation Investment Fund provides grants to eligible small businesses to support the preparation of competitive proposals, and match funds received through SBIR/STTR Phase I and Phase II awards.

## ELIGIBILITY

Small West Virginia-based companies or entrepreneurs that have targeted a specific solicitation from one of the participating federal agencies

**ADMINISTERING AGENCY** | West Virginia Small Business Development Center

**CYCLES** | Applications are accepted during the periods of January 1-31, May 1-31, and September 1-30 each year.

# U.S. DEPARTMENT OF AGRICULTURE (USDA) RURAL COMMUNITY DEVELOPMENT INITIATIVE GRANTS

**FUNDING TYPE** | Federal Grant

## DESCRIPTION

USDA's RCDI grants are awarded to help non-profit housing and community development organizations, low-income rural communities, and federally recognized tribes support housing, community facilities, and community, and economic development projects in rural areas. The minimum grant award is \$50,000 and the maximum grant award is \$250,000. Grant funds are limited and are awarded through a competitive process.

## ELIGIBILITY

Eligible applicants include public bodies, non-profit organizations, and qualified private (for-profit) organizations. Eligible areas include rural and rural areas; any area other than (i) a city or town that has a population of greater than 50,000 inhabitants; and (ii) the urbanized area contiguous and adjacent to such city or town.

**RCDI grants may be used for improving housing, community facilities, and community economic development projects in rural areas. RCDI grants may be used for but not limited to:**

- > Training subgrantees to conduct:
  1. Home-ownership education
  2. Minority business entrepreneur education
- > Providing technical assistance to subgrantees on
  1. Strategic plan development
  2. Accessing alternative funding sources
  3. Board training
  4. Developing successful childcare facilities
  5. Creating training tools, such as videos, workbooks, and reference guides
  6. Effective fundraising techniques

# U.S DEPARTMENT OF AGRICULTURE COMMUNITY FACILITIES DIRECT LOAN AND GRANT PROGRAM

## FUNDING TYPE | Federal • Interest Loan and/or Grant

A combination of the two above, as well as a loan guarantee program. These may be combined with commercial financing to finance one project if all eligibility and feasibility requirements are met.

## DESCRIPTION

This program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area and does not include private, commercial, or business undertakings.

## ELIGIBILITY

### Eligible borrowers include:

- › Public bodies
- › Community-based non-profit corporations
- › Federally-recognized Tribes

### Eligible areas include:

- › Rural areas including cities, villages, townships, and towns including Federally Recognized Tribal Lands with no more than 20,000 residents according to the latest U.S. Census Data
- › Funds can be used to purchase, construct, and/or improve essential community facilities, purchase equipment, and pay related project expenses.

### Examples of essential community facilities include:

- › Health care facilities such as hospitals, medical clinics, dental clinics, nursing homes, or assisted living facilities
- › Public facilities such as town halls, courthouses, airport hangars, or street improvements
- › Community support services such as childcare centers, community centers, fairgrounds, or transitional housing
- › Public safety services such as fire departments, police stations, prisons, police vehicles, fire trucks, public works vehicles, or equipment
- › Educational services such as museums, libraries, or private schools
- › Utility services such as telemedicine or distance learning equipment
- › Local food systems such as community gardens, food pantries, community kitchens, food banks, food hubs, or greenhouses

The WDA is proud to announce its most recent grant program, the Economic Enhancement Grant Fund. The fund is appropriated for \$250,000,000 of the American Rescue Plan Act funds WDA for use on projects across the state. - › Bacon Act wage rates and provide a workforce continuity plan
- › Shall follow Disadvantaged Business Enterprise requirements
- › All funding for the project must be spent by December 31, 2026
- › Must obtain a recommendation from the West Virginia Infrastructure and Jobs Development Council
- › All non-infrastructure projects must have written recommendation from either the Secretary of Commerce, Economic Development, or Department of Tourism
- › The project may be the design of a water system, a wastewater/sewer system, or a stormwater system provided that the design must be complete and ready to bid by December 31, 2024

# RURAL COOPERATIVE DEVELOPMENT GRANT PROGRAM IN WEST VIRGINIA

# OUTDOOR HERITAGE CONSERVATION FUND (OHCF)

**FUNDING TYPE** | State Grant

## DESCRIPTION

The West Virginia Outdoor Heritage Conservation Fund (OHCF) operates two grant programs:

- Small Grant Program (\$5,000-\$25,000) – Eligible grant activities include:  
Due diligence to acquire an interest in real property for conservation purposes, including baseline documentation, environmental hazards assessment, title examination, survey, and appraisal  
  
Stewardship is defined as the necessary monitoring, maintenance, and enforcement of interests in real property for conservation purposes. This includes the stewardship and/or legal defense fund to monitor and protect the interest in real property over time
- Large Grant Program (Over \$25,000) – Eligible grant activities include:  
Capital expenses and transactional costs associated with the purchase of interests in real property for conservation purposes and closing costs

The purpose of having two grant programs is to ensure that important funding needs of eligible applicants are met and OHCF grants leverage non-state dollars.

## ELIGIBILITY

**Eligible applicants include:**

- Nonprofit corporations registered with the West Virginia Secretary of State that have as a primary part of their mission to acquire interests in real property for conservation purposes
- West Virginia Division of Forestry
- West Virginia Division of Natural Resources

The OHCF encourages partnerships to leverage resources for land and water conservation. An eligible applicant may work with organizations that are not eligible applicants to conserve interests in real property. All partners involved in a project must be named on the grant application. In addition, the organizations(s) that will hold the interest in real property or conduct the stewardship must be identified on the application.

## TRANSPORTATION ALTERNATIVES PROGRAM (TAP)

### FUNDING TYPE

TAP is a reimbursable program for nontraditional transportation projects and includes funding for competitively selected projects including the design and construction of on-road and off-road trail facilities for pedestrians, bicyclists, and users of other nonmotorized forms of transportation. ## RECREATIONAL TRAILS PROGRAM (RTP)

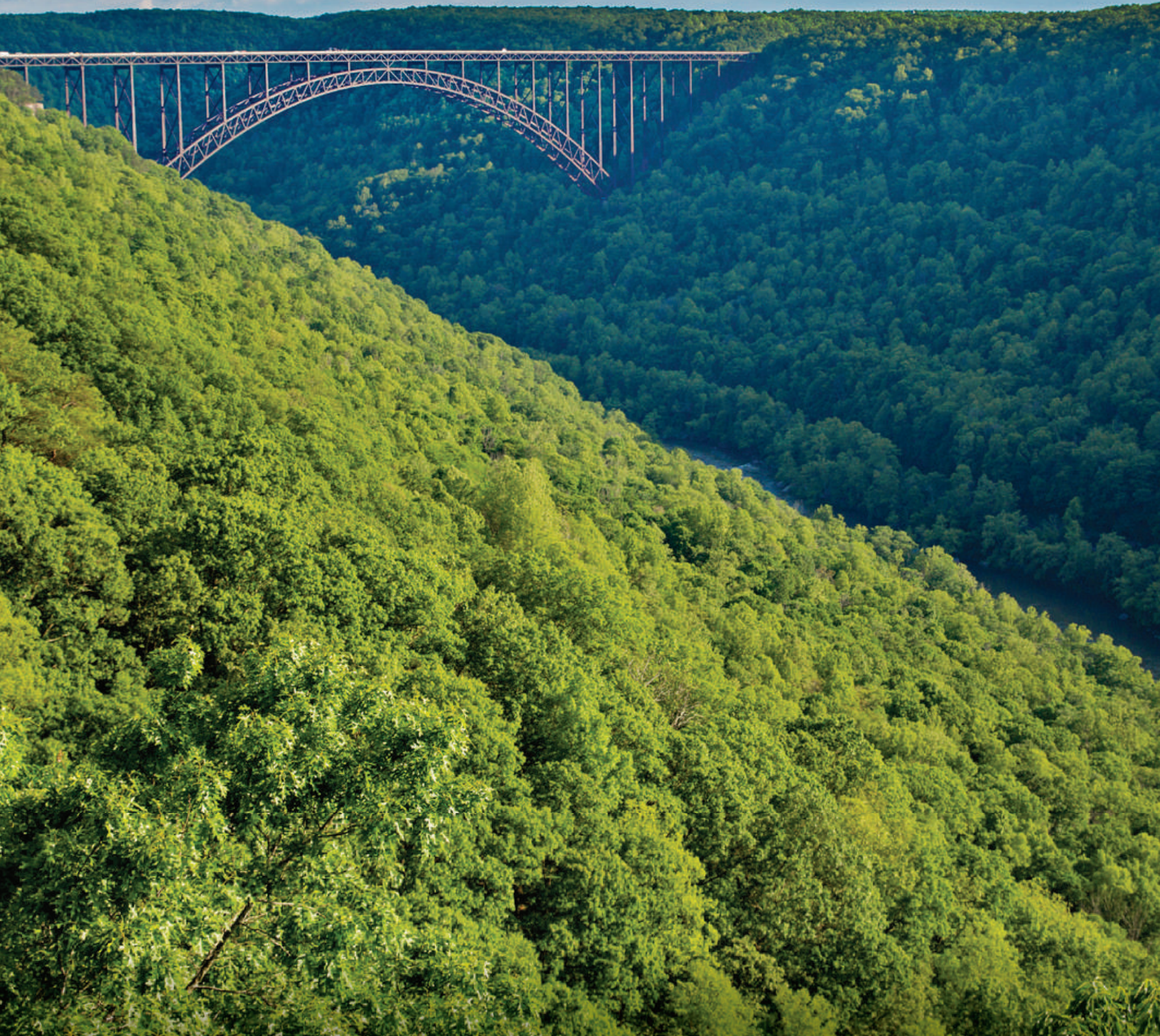

## LAND AND WATER CONSERVATION FUND (LWCF)

**FUNDING TYPE** | Federal Grant

### DESCRIPTION

The LWCF provides supplemental federal funding for the acquisition and/or development of high-quality, public outdoor recreational areas throughout West Virginia. Proposed projects for LWCF funds should be consistent with the Statewide Comprehensive Outdoor Recreation Plan (SCORP). Projects receiving funding priority include park renovations, expansions to promote active lifestyles, projects that innovate community cores, attract or retain visitors to an area, develop trailheads or preserve other natural areas to impact community health objectives, or those which develop brownfield's renewal efforts. Additional priority will be made for projects targeting one or more of the funding priorities that utilize a community coalition or consortium approach towards achieving the project goal. Project consortiums can include, but not be limited to, participation in the West Virginia Department of Economic Development's Main Street Program, Certified Development Community Program, or other programs of the Governor's Office of Healthy Lifestyles, West Virginia Department of Highways, or Northern or Southern West Virginia Brownfields Assistance Centers. Grants are 50/50 reimbursable matching grants.

### ELIGIBILITY

Funds are provided to units of local government, independent park boards, commissions, districts, and state governments

**Eligible activities include but are not limited to the development of outdoor recreation resources related to the following:**

- > Campgrounds
- > Winter sport facilities
- > Swimming facilities
- > Interpretive centers
- > Trails
- > Golf courses
- > Visitor information centers
- > Hunting areas
- > Sports and playfields
- > Lake impoundments
- > Fishing facilities
- > Picnic Areas
- > Amphitheaters
- > Boating facilities
- > Support facilities (walks, utilities, bathrooms, etc.)

## STREAM PARTNERS PROGRAM (SPP)

## THE OFFICE OF ABANDONED MINE LANDS AND RECLAMATION (AML) PILOT PROGRAM

## ARTS IN EDUCATION - MINI-GRANTS

# WEST VIRGINIA FILM INDUSTRY INVESTMENT ACT

## FUNDING TYPE | Tax Credit

### DESCRIPTION

The Film Industry Investment Act is an elimination of film tax credit that occurred to promote economic development through motion pictures and other commercial film and audio projects. The tax credit will provide credits amounting to up to 31% of direct production expenditures in West Virginia. Companies could also be eligible for credits for post-production expenses incurred in West Virginia.

### ELIGIBILITY

Eligible projects are feature-length motion pictures, TV films and series, post-production, music videos, and commercial photography.

**Qualified Spend:** Expenses incurred in WV or with a WV vendor, including:

- › Talent and ATL/BTL crew subject to WV income tax
- › Pass-throughs (use of 3rd party WV production company permitted for acquiring most equipment)
- › Loan-out corporations
- › Airfare purchased through WV-based travel company
- › Insurance and bonding purchased through a WV-based agent
- › Rental of facility and equipment
- › Set construction/operations, wardrobe, accessories, and related services
- › Photography, sound synchronization, lighting, and related services
- › Transportation leasing/rentals
- › Fuel, food, and lodging
- › Editing and post-production-related services
- › Story and scenario
- › Other direct costs

**Unqualified projects include:**

- › Projects that contain obscene matter or sexually explicit content
- › Projects that display West Virginia in a derogatory manner

# SAVING HISTORICAL PLACES GRANT

**FUNDING TYPE** | Nonprofit • Private Donations Grant

## DESCRIPTION

The Saving Historical Places grant is available to provide funding to help nonprofit organizations and individuals save historical buildings in their communities. The purpose of this grant is to respond to emergency stabilization issues in historic buildings and jump-start historic preservation projects by providing funds for pre-development costs. For those wanting to save historical buildings in their communities, one of the first steps is understanding what it will take to rehabilitate the building and if the goal they have for the building is feasible. Minimum grant awards will be \$10,000, and there is no maximum limit. A match is not required. Grant funds can be used as a match for federal grants.

## ELIGIBILITY

To qualify for this grant, properties must be listed or determined eligible for listing in the National Register of Historic Places.

**Saving Historical Places Grant applications will be accepted for emergency stabilization, and planning and pre-development costs, including, but not limited to:**

- › Emergency stabilization construction costs to save the building
- › Feasibility studies
- › Architectural and engineering fees for purposes such as architectural, engineering drawings, or historic structures reports
- › Legal fees for purposes such as title/deed research and transfer of ownership
- › Consultant fees for historic tax credit applications
- › Consultant fees to complete a nomination to the National Register of Historic Places

# BUILD WV TAX CREDIT

## FUNDING TYPE | Tax Credit

### DESCRIPTION

The goal of this program is to assist growing communities across the state and attract new housing development by offering incentives for housing developers:

1. Sales Tax Exemption for Building Materials
2. 10-year Property Value Adjustment Refundable Tax Credit

### ELIGIBILITY

Districts are established:

- > Through Secretaries of Economic Development, Commerce, and Tourism would designate certified districts where housing needs are not met
- > Developers would apply to the Department of Economic Development for residential housing projects to be certified
- > Projects with a minimum cost of \$3m or that include at least six residential units or houses within a certified district

## CYCLES | Applications are accepted throughout the year for qualifying projects.

# AFFORDABLE HOUSING FUND

**FUNDING TYPE** | State Grant • Technical Assistance

## DESCRIPTION

The Legislature created the Affordable Housing Fund in 2001 to provide funding for both technical assistance and housing assistance to nonprofits and government entities and to encourage stronger partnerships, collaboration, and greater involvement of local communities in meeting housing needs in West Virginia. The funding is designed to provide financial assistance to eligible organizations which focus on providing and preserving affordable housing in West Virginia. Projects are funded for up to \$300,000.

## ELIGIBILITY

### Eligible Borrowers

- > Local governments and local government housing authorities
- > Nonprofit organizations recognized as exempt from federal income tax under section 50 (c)(3) and that assist low and moderate-income citizens of this state

### Ineligible Borrowers

- > HUD's Excluded Parties list
- > Delinquencies of 30 days on two or more occasions during the previous 12 months, or delinquencies of 60 days on one or more occasion(s) during the previous 12 months on any WVHDF loan
- > Uncured default on any WVHDF loan
- > Foreclosure within the past 10 years on any WVHDF loan
- > Unresolved material audit findings, particularly related to funds management or compliance with federal program requirements, during the most recent three-year period Issues of non-compliance with the WVHDF that continue to be unresolved after the end of the correction period, and continue to be unresolved at the time any such proposed loan is under consideration, or a history of repeated compliance issues
- > Adverse public findings

**ADMINISTERING AGENCY** | West Virginia Housing Development Fund

**CYCLES** | Completed applications are accepted throughout the year. General applicants will be notified within 90 days of the receipt of a complete application.

# THE HOME PROGRAM

**FUNDING TYPE** | State Grant

## DESCRIPTION

The primary objective of the HOME program is to expand the supply of decent, safe, sanitary and affordable housing, primarily rental housing; to strengthen the abilities of state and local governments to provide housing; to ensure that federal housing services, financing, and other investments are provided to state and local governments in a coordinated, supportive fashion; to expand the capacity of nonprofit community-based housing development organizations, and to leverage private sector participation in financing affordable housing.

## ELIGIBILITY

**Developers and owners of affordable rental housing – including for-profit developers, nonprofit developers, public housing authorities, and Fund-designated for HOME funding subject to the program- specific limitations are noted below:**

- While public housing authorities are eligible to apply, public housing units supported by Public Housing Capital or Operating funds authorized by the 1937 Act are not eligible for HOME funding. Non-public housing units owned and developed by a public housing authority are eligible.
- CHDOs are a specific type of community-based nonprofit organization defined by section 24 CFR 92.2 of the HOME Final Rule. The HOME program includes an annual set-aside of funds for projects owned, developed, or sponsored by CHDOs. Prior to committing funds, the Fund will review the status of any organization seeking funds from the CHDO set aside to ensure that it meets all HOME requirements, that it has sufficient staff capacity to carry out the project, and that the CHDO meets the requirements of “owner,” “developer,” or “sponsor” as required by 24 CFR 92.300(a).
